Our Vision:



Special Projects: Wastewater Pre-Apprenticeship Program

Community collaboration between OhioMeansJobs-Allen County, Rhodes State College, Allen County Sanitary Engineers and City of Lima-Utilities Department. The goal of the program is to help fulfill the workforce gap in this occupation by producing a pipeline of skilled individuals, and focusing on local youth to provide the skills, education and on-the-job training in wastewater operations.

- ➢ 8 local youth were chosen (ages 18-24)
- > All 8 successfully completed the academic instruction and on-the-job training hours
- ▷ 5/8 will continue to a Registered Apprenticeship Program to become a Class I Operator starting September 2019 and will sit for the Operator in Training (OIT) certification in November 2019.
